At no time did Amity Univ. have any license or authority for this use.

This use was done with the reckless disregard or willful blindness to my client's rights as set forth in the Copyright Act, 17 U.S.C. § 106, entitling my client to enhanced statutory damages of up to \$150,000, but not less than \$30,000 pursuant to 17 U.S.C. § 505(c). Further, Amity Univ. failed to include information which identified the Copyrighted Recording, the author of the Copyrighted Recording, the owner of any right in the Copyrighted Recording, or information about the terms and conditions of use of the Copyrighted Recording in violation of the Digital Millennium
